**SETTING FEES FOR STORMWATER MANAGEMENT AND EARTH
DISTURBANCE PLAN REVIEWS BY THE HEIDELBERG TOWNSHIP ENGINEER**

WHEREAS, this Township, in Ordinance 105, enacted Stormwater Management Ordinance for Heidelberg Township; and

WHEREAS, said Ordinance, in section 704, provided that the Board of Supervisors of this Township shall establish by resolution a collection procedure and schedule of fees to be paid by applicant under said Ordinance; and

WHEREAS, the Board of Supervisors of Heidelberg Township finds that the rules and regulations which govern Stormwater have changed significantly, therefore giving rise to the need for significant more expenditure of Township Staff and Township Engineer effort to review plans and administer the Stormwater Ordinance, therefore giving rise for the need to amend the existing fee schedule.



Storm Water Management Agriculture Exemption Requests

- * Acreage of tract to be based upon acreage of disturbed land area identified on the Township application; stipulated in the Erosion and Sedimentation Control Permit application, as applicable; or, as stipulated in the NPDES Permit application, as applicable, whichever is greater.

Notes

1. All fees for each plan are due at the time the plan is filed. If the correct fee is not paid, the filing is not complete and all plans will be returned by the Township to the Applicant.
2. Monies paid to the Township which are not used for the cost of reviewing the Storm Water Management Plan or Exemption request, will be refunded to the Applicant.
3. Should the cost of reviewing the Storm Water Management and Earth Disturbance Plan exceed the amount of the plan review fee which the Applicant has paid to the Township, the Applicant shall pay to the Township the amount in excess of the fees which have been expended, in addition to the original review fee, in reviewing the Storm Water Management and Earth Disturbance Plan, plus any additional fees as noted below, within thirty (30) days of notification.
4. Should the balance in the Applicant's account drop below one-half of the original review fee and if the review process is on-going, the Township shall require a minimum of one-half of the original review fee, including the non-refundable portion, be maintained in the account.
5. If a major revision to a plan is submitted, the applicant shall submit, with the revised plan, a fee equal to one-half of the original plan review fee for that particular plan stage, including the non-refundable portion.
6. The applicant shall pay the Township Construction Observation fees on a time and expense basis plus 5% for Township administration of the project. The fees shall be based on the attached fee schedule.
7. All agreements and agreement fees should be prepared and paid by the applicant.

1. Travel to and from the job site from the nearest office is chargeable time, with project mileage at \$0.50 per mile.
2. Client directed overtime is charged at 1.5 times base rate.
3. Job function controls over individual position – that is, if a Graduate Engineer is doing CAD drafting work, the client would be charged the lower rate.
4. Cost for plan copies is \$0.55 per square foot.
5. Project expenses are charged at cost. Extraordinary sub-consultant expenses, such as soil borings costs or testing laboratory charges shall be specifically approved by the client, prior to the engagement of the sub-consultant.
6. A special rate of \$150.00 per hour is established for formal hearings and court appearances as an expert witness for a Professional Engineer, Geologist, Surveyor, or other professional.
7. Field equipment usage will be charged as follows: Sewage Flow Meter - \$10.50/day, Traffic Counter - \$54.50/day, GPS Locator - \$22.50/day, RTKGPS - \$205.00/day, SUB-RTKGPS - \$50.00/day, Push Camera - \$10.00/hour for Televising, Push Camera - \$12.00/hour for Televising and Locating Services.
