## ONLINE PARCEL VIEWER AVAILABLE FROM COUNTY

In September 2017 the Lebanon County GIS Department launched the Lebanon County Online Property Viewer. This web-based geographical property viewer enables individuals to look at a map of Lebanon County and gain basic information about any property with a simple click.

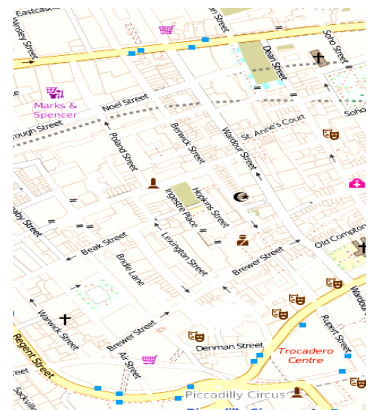
To see this application, visit [www.lebcounty.org](http://www.lebcounty.org), scroll down to Quick Links and click on Lebanon County Property Viewer. To find out how to use all aspects of the site, click on Property View User Handbook and instructions on how to navigate the site will open also.

Once on the application a map will appear after agreeing to the terms of the site. You have the option of zooming to see a birds-

eye view of a property or searching a specific property by address or parcel number. Once you've located a property you can click on it and an information box will pop up with owner, sale, size and assessment information. All of this information is public and can be found at the Lebanon County courthouse as well.

There are a number of tools available on the Property Viewer to gain more knowledge of an area. Measuring tools for multiple measuring options, topographical view options and the ability to print PDF versions of viewable maps are all some of the items available for use on the site.

We appreciate Lebanon County initiating this endeavor to make information easier to obtain. What once required a trip to the courthouse is now a click away!

## MUNICIPAL AUTHORITY CHANGES

The only thing that remains constant is change. That statement is as prevalent in Heidelberg Township as it is on a global scale. A recent change in Schaefferstown is the vacating of the Municipal Authority.

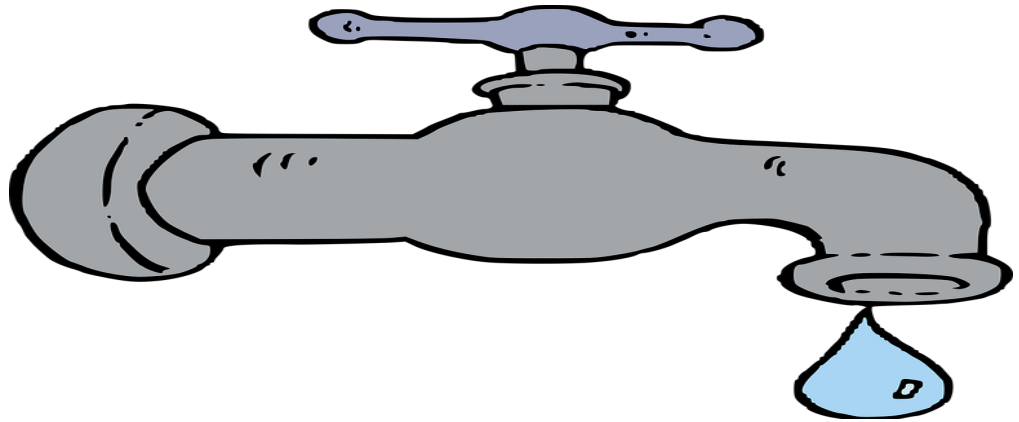
For more than two years, the Heidelberg Township Board of Supervisors has been running the general operations of the Municipal Authority. The HTMA Board members that last served resigned and turned over the responsibilities to the Township Board of Supervisors. The majority of users have seen little to no change in general operations, but because the Township has not been the actual owner of

the water system, there were tasks that were unable to be performed legally.

In September 2017, that changed when legal documents were drawn in order to transfer all assets of HTMA to Heidelberg Township. What does this mean to the users of the water system? Not much at this point. Changes that you will notice beginning in 2018 will be quarterly invoice design and to whom you make your check payable. The quarterly bill that will be mailed in January will still be on blue paper, but will be the same size and same design as the sewer bill. When paying your bill, you may make

checks to Heidelberg Township or HTWS (Heidelberg Township Water System) and mail to PO Box 188, Schaefferstown.

All efforts are being made to make this transition as seamless as possible. The Board of Supervisors is proactively trying to work with Select Environmental, water operator, in detecting needed repairs and ways to improve the water service in Schaefferstown. ## ON-LOT SEPTIC PROGRAM WILL BEGIN IN 2018

Although previously planned, in 2018 Heidelberg Township will begin implementation of the On-Lot Sewage Disposal Program as required by DEP for those areas with on-lot sewage systems. This program is designed to maintain working on-lot sewage systems to prevent contamination of ground soil and well water. It will be administered

by the Lebanon County Planning Department and Sewage Enforcement Officer David Siminitus and Michelle Faschnacht.

Many residents prepared for this program when it was originally started to begin and we thank you for that. Circumstances were just not optimal for all parties involved to start the program when everyone

thought it could. But at this time, anyone with an on-lot septic system on their property that is not connected to the public sewer system should be prepared to participate. Mailings to property owners that will need to participate should be sent in early spring. Should you have any immediate questions, please call the Lebanon County Planning Department at 717-228-4444.

## UNITED WAY 2-1-1 SERVES LEBANON COUNTY

The United Way of Lebanon County has recently instituted at social service hotline as a means to distribute resource information to Lebanon County residents. Now simply dialing 2-1-1 enables county residents to obtain local program information 24 hours a day 7 days a week.

The “one stop shop” phone number enables a caller to speak to a trained call specialist who will give information on local resources based on

their needs. While this is not a substituted for an emergency 9-1-1 call, this service may take the place of some of the calls made to that system which are only information based. The human services workers who answer the calls placed to 2-1-1 have quick access for service or program information to answer client needs. Examples of service information obtainable at the 2-1-1 number are housing, food, disaster, transportation, substance abuse and veteran/military needs.

Again, this number is only for non-emergency needs. If there is a medical crisis, 9-1-1 is always the first phone call. But, if information is what you seek, you have more options through the United Way.
