Dear Resident,

The County Commissioners have awarded a bid for the replacement of county-owned bridge CO-1, commonly known as the Red Bridge, on Michter's Road. The bid was awarded to Jay Fulkroad and Sons, Inc., from McAllistersville, PA. Obviously, the bridge will need to be closed for the duration of the project, which is expected to begin in the latter part of this month, and last until the beginning of December. At this point, my best estimate for the closure is Monday, June 24<sup>th</sup>.

Due to the closure of the bridge, deliveries and USPS mail will need to be handled differently for residents on the south side of the bridge. I have been in contact with Jamie Heck, Postmaster of the Newmanstown Post Office, and she has indicated there are four mail delivery options available to residents on the south side of the bridge. They are as follows:

1. Mail may be picked up at the Newmanstown Post Office during business hours.
2. Mail may be picked up at the Schaefferstown Post Office during business hours.
3. Mail may be picked up at the Kleinfeltersville Post Office during business hours (afternoon only).
4. Mail may be picked up at a box provided in the vicinity of Michter's and Obie Roads (exact site TBD).

Please contact Postmaster Heck at the Newmanstown Post Office to indicate which of these options you choose. The county will provide and erect mailboxes for option number 4, however, we will need sufficient time. Therefore, it is imperative that you communicate your choice to Postmaster Heck by Thursday, June 20<sup>th</sup>. She can be reached at (610)-589-4742.

We appreciate your understanding and patience during this construction, and we all look forward to a safe, modern bridge that will serve the area for many years to come.
